Trucks:

PMs are done, 76 fixed, there is still an issue with 75 and with Campbell. 3-75 has slight oil leak and slight exhaust leak, not covered by Campbell, will see if Defender can fix; Ian reviewed PM items for each truck;

3-76 several exhaust leaks, back of manifold, officer side wiper no good, brakes good;

3-77, brakes good;

3-87 brakes good, needs air filter

3-90 oil pan leak; rubber bumper needs repair; driver side mirror;

3-95 belt missing; brakes 60%; oil leak at pan rear
