Resolution No. 2023-

RESOLUTION RATIFYING AN EMERGENCY CONTRACT AWARD TO AIR & GAS TECHNOLOGIES, INC., FOR THE REPLACEMENT OF A BREATHING AIR COMPRESSOR

WHEREAS, the Board of Fire Commissioners of Fire District No. 3, Township of Marlboro, County of Monmouth, State of New Jersey, is charged with the prevention and extinguishment of fires and the regulation of fire hazards within Fire District No. 3 (N.J.S.A. 40A:14-81); and

WHEREAS, in furtherance of its mandated charge, the District utilizes a breathing air compressor designed to deliver high pressure breathing air, in compliance with the most current NFPA and CGA air quality standards, for the refilling of cylinders for self-contained breathing apparatus (SCBA) for firefighting purposes; and

WHEREAS, in the course of operations, the Board of Fire Commissioners of Fire District No. 3 was notified of a circuit board failure within its breathing air compressor which cannot be repaired as the unit is obsolete in that said unit is not rated for the 4500psi SCBA bottles utilized by the District; and

WHEREAS, the Board found and determined that it is necessary to replace the breathing air compressor immediately to protect the health, welfare and safety of the public; and

WHEREAS, the Board determined that an emergency existed and secured a vendor, Air & Gas Technologies, Inc., that can replace the breathing air compressor immediately; and

WHEREAS, the legal voters of Fire District 3, on August 15, 2023, affirmatively voted to authorize the Board of Fire Commissioners of Fire District No. 3, Township of Marlboro, County of Monmouth, State of New Jersey, to expend an amount not to exceed \$70,000.00 for the purchase of a replacement breathing air compressor; and

WHEREAS, the Board received from Air & Gas Technologies, Inc., all supplemental documentation which complies with the laws of the State of New Jersey for entities awarded a contract by a public entity; and

WHEREAS, the New Jersey State Treasurer has determined that contracts awarded under emergency conditions pursuant to N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1 et seq. may be awarded without complying with the Pay to Play Law, N.J.S.A. 19:44A-20.4, et seq.; and

WHEREAS, the Board Treasurer certifies that the legal voters within the District authorized the Commissioners of Fire District No. 3 to expend in an amount not to exceed \$70,000.00 for the heretofore mentioned purchase, which funds are available.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 3, Township of Marlboro, County of Monmouth, State of New Jersey, that an emergency contract award to Air & Gas Technologies, Inc., 42 Industrial Drive, Cliffwood Beach, New Jersey 07735, pursuant to N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1, et seq., for a Bauer Unicus 4S 13H-E3 SCBA Cascade Air Compressor and Filling Station in the amount of sixty-eight thousand three hundred forty-five dollars (\$68,345.00) is hereby ratified; and

BE IT FURTHER RESOLVED, that, pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds shall be certified as of the date of the within Resolution and shall be chargeable as incurred to the maximum amount of same unless otherwise increased as permitted by law and a separate certification of availability of funds is made by the Board Treasurer; and

BE IT FURTHER RESOLVED, that the Board Treasurer shall file an emergency procurement report for this contract award with the Director of the Division of Local Government Services; and

BE IT FURTHER RESOLVED, that the Board Chairman and Board Treasurer are authorized to take such other actions as may be necessary to effectuate the intent and purpose of this Resolution; and

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED, that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, et seq. and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, et seq. as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.

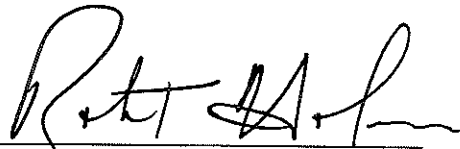

EMERGENCY PROCUREMENT REPORT

Public Exigencies Pursuant To N.J.S.A. 19:44A-20.12

Procedure

An Emergency Procurement Report is required when municipalities, counties, and their instrumentalities and agencies¹ (public agency) experience an emergency that warrants the immediate delivery of goods or services and in doing so, are unable to comply with the “Pay-to-Play” provisions of N.J.S.A. 19:44A-20.4 et seq. N.J.S.A. 19:44A-20.12 provides in pertinent part that:

“Nothing contained in this act shall be construed as prohibiting the awarding of a contract when the public exigency requires the immediate delivery of goods or performance of emergency services as determined by the State Treasurer.”

The State Treasurer² has determined that approval under this provision is automatically granted when:

1. A public agency finds the public’s health, safety or welfare requires the immediate delivery of goods or the performance of services.
2. The award of any such contracts is made pursuant to the provisions of N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1 et seq., or for county colleges, N.J.S.A. 18A:64A-25.6.
3. Contracts are issued in response to a formal declaration of an emergency by the Governor.

Emergency Report Required

The Treasurer also requires that when a contracting agency uses these provisions, the agency’s purchasing agent or other appropriate personnel shall file with Director of the Division of Local Government Services an “Emergency Procurement Report,” within 30 days of the date the contract was issued. Contracts relating to a formal declaration of an emergency by the Governor are exempt from the reporting provision.

Certain information is necessary to address situations in which an exigency/emergency affecting the public’s health, safety or welfare requires the immediate delivery of goods or the performance of services.

Legal Provisions Related to Use of Emergencies

40A:11-6 Emergency contracts

6. Emergency contracts. Any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefor, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; provided that the awarding of such contracts is made in the following manner:

- a. The official in charge of the agency wherein the emergency occurred, or such other officer or employee as may be authorized to act in place of that official, shall notify the purchasing agent, a supervisor of the purchasing agent, or a designated representative of the governing body, as may be appropriate to the form of government, of the need for the performance of a contract, the nature of the emergency, the time of its occurrence and the need for invoking this section. If that person is satisfied that an emergency exists, that person shall be authorized to award a contract or contracts for such purposes as may be necessary to respond to the emergent needs. Such notification shall be reduced to writing and filed with the purchasing agent as soon as practicable.
- b. Upon the furnishing of such goods or services, in accordance with the terms of the contract, the contractor furnishing such goods or services shall be entitled to be paid therefor and the contracting unit shall be obligated for said payment. The governing body of the contracting unit shall take such action as shall be required to provide for the payment of the contract price.
- c. The Director of the Division of Local Government Services in the Department of Community Affairs shall prescribe rules and procedures to implement the requirements of this section.
- d. The governing body of the contracting unit may prescribe additional rules and procedures to implement the requirements of this section.

N.J.A.C. 5:34-6.1 General requirements (edited as to applicability)

- (a) The use of emergency purchasing pursuant to N.J.S.A. 40A:11-6 or 18A:18A-7 shall be subject to the following requirements:
 1. An actual or imminent emergency must exist requiring the immediate delivery of the goods or the performance of the service;...
 - ...3. The emergency purchasing procedure may not be used unless the need for the goods or services could not have been reasonably foreseen or the need for such goods or services has arisen notwithstanding a good faith effort on the part of the contracting unit to plan for the purchase of any goods or services required by the contracting unit;
 4. The contract shall be of such limited duration as to meet only the immediate needs of the emergency; and
 5. Under no circumstances shall the emergency purchasing procedure be used to enter into a multi-year contract.
- (b) The governing body of each contracting unit shall adopt rules or regulations as appropriate to the contracting unit to ensure that there is a procedure for determining and confirming the existence of an emergency and that the provisions for emergency purchasing pursuant to N.J.S.A. 40A:11-6 or 18A:18A-7 may be implemented. Such rules or regulations shall include such provisions that ensure that if initially designated individuals are not available, there is a designated chain of command to ensure that there are always appropriate individuals available to make such decisions.

18A:64A-25.6 Emergency purchases and contracts

6. Any purchase, contract, or agreement may be made, negotiated or awarded by a county college without public advertising for bids and bidding therefor, notwithstanding that the cost or contract price will exceed \$25,000* or, commencing January 1, 2003, the amount determined pursuant to subsection b. of section 3 of P.L.1982, c.189 (C.18A:64A-25.3), when an emergency affecting the health, safety or welfare of occupants of college property requires the immediate delivery of the materials or supplies or the performance of the work, provided that such purchases, contracts or agreements are awarded or made in the following manner:
- a. A written requisition for the performance of such work or the furnishing of materials or supplies, certified by the employee in charge of the building, facility or equipment where the emergency occurred, is filed with the contracting agent or his deputy in charge, describing the nature of the emergency, the time of its occurrence, and the need for invoking this section. The contracting agent, or his deputy in charge, being satisfied that the emergency exists, is hereby authorized to award a contract for said work, materials or supplies.
 - b. Upon the furnishing of such work, materials or supplies in accordance with the terms of the contract or agreement, the contractor furnishing such work, materials or supplies shall be entitled to be paid therefor and the county college shall be obligated for said payment.
 - c. The board of trustees may prescribe rules and procedures to implement the requirements of this section.

RESOLUTION AWARDING CONTRACT TO AIR & GAS TECHNOLOGIES, INC.,
THROUGH USE OF THE NPPGOV PROCUREMENT PROCESS
PURSUANT TO N.J.S.A.52:34-6.2(B)(3)

WHEREAS, the Board of Fire Commissioners of Fire District No. 3, Township of Marlboro, County of Monmouth, State of New Jersey, is charged with the responsibility of fire suppression, protection and prevention within the Township of Marlboro; and

WHEREAS, in order to fulfill its mandated responsibility as set forth above, the Board finds and determines a need to purchase a Bauer Unicus 4S 13H-E3 SCBA Cascade Air Compressor and Filling Station; and

WHEREAS, the Board is authorized to use what is commonly known as an alternate method of procurement (National Cooperative) pursuant to N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, NPPGov is a national cooperative procurement organization based in Seattle, Washington, operating under the Revised Code of Washington, Title 39 (Public Contract & Indebtedness), Chapter 39.34 (Interlocal Cooperation Act); and

WHEREAS, the Board, by Resolution, authorized participation in said NPPGov, a recognized National Cooperative, and entered into a contract to effectuate same; and

WHEREAS, the Board published a Notice of Intent to utilize the NPPGov process for procurement of a Bauer Unicus 4S 13H-E3 SCBA Cascade Air Compressor and Filling Station on August 11, 2023, and provided a time period for public comment on same; and

WHEREAS, thereafter, the Board received information and pricing on a Bauer Unicus 4S 13H-E3 SCBA Cascade Air Compressor and Filling Station; and

WHEREAS, the Board conducted a cost analysis and established that entering into the alternate procurement method through NPPGov would be the most effective contractual solution to the purchase of the needed Bauer Unicus 4S 13H-E3 SCBA Cascade Air Compressor and Filling Station; and

WHEREAS, the Board received from Air & Gas Technologies, Inc., all supplemental documentation which complies with the laws of the State of New Jersey for entities awarded a contract by a public entity.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 3, Township of Marlboro, County of Monmouth, State of New Jersey, that, pursuant to said statute made, it enter into a contract to purchase a Bauer Unicus 4S 13H-E3 SCBA Cascade

Air Compressor and Filling Station from Air & Gas Technologies, Inc., 42 Industrial Drive, Cliffwood Beach, New Jersey 07735, through NPPGov in the amount of sixty-eight thousand three hundred forty-five dollars (\$68,345.00); and

BE IT FURTHER RESOLVED, that the within expenditure in the proposed amount was authorized by referendum at a special meeting on August 15, 2023, and that the sum of sixty-eight thousand three hundred forty-five dollars (\$68,345.00) appears in the 2023 budget under the caption of restricted capital projects and is hereby appropriated under the said caption of the Capital Improvements section of the 2023 budget; and

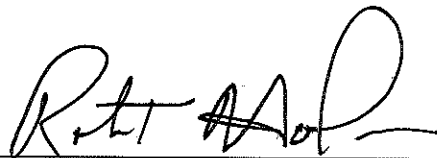
