The proposed 2026 annual budget reflects a 18.9% increase compared to the 2025 budget, driven by adjustments in debt service and the increase in expenses. Notable changes include increased principal and interest payments for debt and increased allocations for administrative salaries and office expenses, cost of operations: insurance, hydrant rentals, rent, utilities, turnout gear and volunteer incentive program.

The proposed 2026 annual budget reflects a 18.9% increase in the amount to be raised by taxation when compared to the 2025 budget, driven by adjustments in debt service and the increase in expenses. Notable changes include increased principal and interest payments for debt and increased allocations for administrative salaries and office expenses, cost of operations: insurance, hydrant rentals, rent, utilities, turnout gear and volunteer incentive program. The district remains in full compliance with the tax levy cap, with a tax rate increase of \$0.018 per \$100 when compared to the 2025 budget.

No, the district remains in full compliance with the tax levy cap.

The proposed 2026 annual budget reflects a 75% decrease in capital appropriations and an increase of 57.8% on principal debt service payments and a 142.2% increase in interest payments on debt service, respectively when compared to the 2025 budget. This reflects the addition of the debt service for a new ladder truck and the District converting the BAN into bonds.
